III. BOOKING DETAIL

Party B agrees to participate and rent standard booths (outdoor space) and advertisement services in the Danang EWEC International Exhibition 2007 from Aug 27th to Sep 1st, 2007 as follow:

1. Standard booth inside: 3m x 3m (L x W) = (including 10% VAT)

Exhibitors set up themselves (excluding electricity, carpet and pay the fee when using electricity, only registered outdoor space to be used).

3. Advertisement: (including 10% VAT)

Billboards to be hung inside and on the fence of the fair area

Fee of Billboards (1m x 3m):.....* 10 USD/1billboard =(exhibitors set up themselves). Exhibitors have to submit logo, maquette to the Board of Organization Danang EWEC International Exhibition 2007 to make the advertisement license.

Total:.....USD. Exhibitors pay 50% of contract value by cash or cheque into The Board of Organization's account right after signing the contract.

IV. COMMON TERMS

- The application form is not erased, repaired and only valued when exhibitors pay in advance 50% of contract value. Deposit will not be refunded if exhibitors do not join the fair.

- Party B pays 50% of the remaining of contract value to be the Board of Organization 10 days prior to the opening ceremony. After 100% contract value is paid and the Fair- Exhibition closed; the application form will be considered to be terminated.

- Party B ensures to display registered commodities and not sell expired commodities and counterfeit goods. Exhibitors who have actions breaking the regulations will take full responsibility under Vietnamese law.

- Vietnamese and overseas traders join the Fair have to strictly fulfill Decree N° 37/2006/ND-CP dated 04th April 2006 by the Vietnamese Government about assign detail the trade promotion activities of the Trade law.

- Party B takes his responsibility for the human and commodities during the fair, must send a list of commodities to party A before day of August 1st 2007 for doing the custom formalities and allowed by the Vietnamese authorities.

- Party B has to inform to the Board of Organization when using electricity of higher capacity or exceeding the limit and pay the fee of 0.1125 USD/Kw (if any).

- Party B has responsibility to protect the assets hired from the Board of Organization; drilling, gluing ... to damage walls, bend aluminum frames are not allowed. If damages or lost, they have to be compensated as reality.

- Party B use space registered (Exhibitors who have actions breaking the regulations will be treated by the Board of Organization). All fire and explosion prevention regulations and the Board of Organization's regulations have to be fulfilled.

- Party A fulfills the general security, hygiene of the fair

- Party A supports Party B in the hired equipment (tables, lamps, fans, displayed cabinet, advertised and displayed commodities and sale- person).

- Party A has responsibility to supply a financial invoice to Party B

- Both sides (Party A and Party B) commit to carry out all articles written in the application form, canceling and repairing by any party is not allowed. In the implementation, any party violating the contract has to compensate the other party all the damages caused by the violation. Any disputes are not settled by themselves will be solved by the current law.

- This application form is considered to be terminated after the fair ends and both sides finish their obligation as mentioned above.

- This application form is made into 02 originals, each party keeps 01 of the same value.
